

Greetings,

At the UGCC meeting on 4/07/06 the following items were addressed:

1. The Consent Agenda was approved unanimously. The following items were included in this agenda:
  - a. adding BUS 3516 Enterprise Resource Planning Systems to the curriculum
  - b. adding BUS 3517 Information Assurance and Security to the curriculum
  - c. adding BUS 4516 Global Strategic Management of Technology to the curriculum
  - d. adding BUS 4585 Information Management Practicum to the curriculum
  - e. adding BUS 3518 Global eCommerce Technology to the curriculum
  - f. adding BUS 4518 eBusiness Design and Implementation to the curriculum
  - g. adding BUS 4785 eCommerce Technology Practicum to the curriculum
  - h. adding HUM 2140 World Architecture to the curriculum
  - i. adding HUM 2141 World Art History 1 to the curriculum
  - j. adding HUM 2142 World Art History 2 to the curriculum(The approved forms have been sent to the Registrar.)
2. Adding the new course BUS 1801 Global Business Perspectives was approved unanimously. (The approved form has been sent to the Registrar.)
3. After replacing "Computer Literacy modules" (which is not an approved course) with BUS 1601 in each program, the requests to change the graduation requirements in the following majors were approved unanimously:
  - a. Business Administration
  - b. Accounting
  - c. Management Information Systems
  - d. Business and Environmental Studies
  - e. Information Systems in Business(The approved forms have been sent to the Registrar.)
4. After replacing "Computer Literacy modules" (which is not an approved course) with BUS 1601 in each program, the requests to add the following two majors were approved unanimously:
  - a. Information Management
  - b. e-Commerce Technology(The approved forms have been sent to the Registrar.)
5. After much discussion, the request to change the prerequisites for BUS 2303 was approved, after removing all prerequisites, with two opposed. Those opposed argued that there should be some math requirement for Macroeconomics, especially a course at the 2xxx level. Those in favor of the final changes argued that if the math requirements were as low as MTH 0111 as a corequisite then it would be simpler to have no requirements at all. If the course does require higher level math, then a new change should be submitted to the Committee. (The approved form has been sent to the Registrar.)

6. The request to change the prerequisites for AHF 3101 was approved with four opposed and two abstentions. There was concern that all prerequisites were being dropped for the 3xxx-level course. This will allow a first year student to take this course.
7. The request to add a new course, COM 3045 Intercultural Communication, to the curriculum was tabled unanimously. Again, the Committee was concerned about a 3xxx-level course with no prerequisites. Since the course does involve writing, a minimum prerequisite of COM 1101 was suggested.
8. The Committee noted the problems students encounter when they already have taken a course listed as a corequisite for a course on their registration form. Apparently, even if the corequisite also is listed as a prerequisite, the corequisite takes precedence in Banner because Banner views a corequisite as a course that must be taken at the same time. The Registrar's office is notifying students of this situation each semester to allow an override of the flag.
