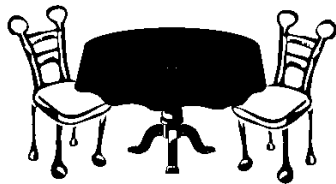

Rental Invoice Terms and Conditions

1. Rentals are payable in **ADVANCE** unless other terms have been established. Renter agrees to pay attorney fees, collection fees, court costs, and any other expenses incurred in collecting any charges under this agreement.
2. The renter will be liable for any equipment lost, stolen or damaged. Unless the renter accepts the DWC (as specified in paragraph 3) the renter shall also be responsible for any damages.
3. **DAMAGE WAIVER CHARGE:** If you pay the Damage Waiver Charge (DWC) as specified, subject to the limitation and exclusions below, Chairs for Affairs Party Rentals, Inc. agrees to modify the terms of this contract and relieve you of liability for accidental damage to the rented item (s) on this contract and for loss due to fire, collision, windstorm, upset and riot. We exclude from this waiver, however, any loss or damage due to theft, burglary, misuse or abuse, theft by conversion, intentional damage, mysterious disappearance or any loss due to your failure to care for the rental item(s) as a prudent person would his/her own property. If any such loss tends to indicate a crime may have been committed, a further condition of this waiver is that you must file a report to the proper law enforcement authorities and furnish us with a copy. In addition, if you have insurance for the loss or damage, you shall exercise and shall empower us to exercise all your rights to obtain recovery under insurance, shall cooperate with CHAIRS FOR AFFAIRS PARTY RENTALS, INC. to obtain recovery and all insurance proceeds shall be given or assigned to CHAIRS FOR AFFAIRS PARTY RENTAL, INC. DAMAGED ITEMS MUST BE RETURNED FOR VERIFICATION.
4. All dishes, glasses, flatware, cooking equipment, etc. **MUST BE RETURNED CLEAN.** If there is food/liquid left on these items CHAIRS FOR AFFAIRS PARTY RENTALS, INC. will charge a cleaning fee for these items. Extra Cleaning fee's start at \$50.00.
5. A 25% deposit is required to reserve items and is non-refundable if job or items are canceled. All cancellations after deposit has been taken will be charged 25% of their value and does not get applied to the total. Cancellations 3 days before event will be 50% fee of their value. Cancellations the day of event are 100% their value.
6. All items on delivery have been checked and counted - **PLEASE VERIFY** - and will again be checked and counted when returned. The customer is responsible for all shortages. Please return items in the same condition as you received.
7. Inactive crew time will be assessed at \$22.50 per half hour per man.
8. Lessor assumes no responsibility for damage or injury sustained by the use of our merchandise or equipment while in your care.

9. We are as careful as possible, but due to the nature of our work, CHAIRS FOR AFFAIRS PARTY RENTALS, INC. IS NOT RESPONSIBLE for any damage to shrubs, trees, underground systems, etc.

10. Please be advised staples, heavy-duty tape, candle wax and some stains may permanently damage the linens. Renter returning damaged linens will be charged rental plus full replacement cost. Lost linen will also be charged rental plus full replacement.

11. Linens that are special ordered are required to be paid in full two weeks prior to the event. Any Page 1 cancellations will be penalized 50%. Cancellations one week prior to the event will not be refunded, also to include shipping costs. All sashes must be untied of bows and knots. A fee of 50¢ per sash will apply if returned tied. Do not return linens wet. It is your responsibility to air-dry them to avoid mildewing. If linens are returned with mildew, you will be responsible for full replacement.

12. Per FSS812.155, "Failure to return property or equipment upon expiration of the rental period and failure to pay all amounts due (including costs for damage to the property or equipment) are evidence of abandonment or refusal to deliver the property, punishable in accordance with section 812.155, Florida Statutes".

This Rental Agreement ("Agreement") is made by and between PopNoggins, LLC a Florida corporation d/b/a Absolute Amusements, Absolute Event Experience, Fliptastic Photos, Flip Movies, Bobble Noggins (hereinafter called "Lessor") and Florida Institute of Technology (hereinafter called "Lessee") on this day of 10/30/2018 WHEREAS, Lessor is engaged in the business of leasing event equipment and services on a short term basis to customers for use at shows, events and other exhibitions; Whereas, Lessee wishes to rent from Lessor such event equipment and services for use at a show, event or exhibition.

Therefore, it is mutually agreed as follows:

1. LEASE: Lessor hereby leases to Lessee and Lessee hereby leases from Lessor, the game machines, personal property and equipment more particularly described in the attached Equipment Schedule. The Rental of the Equipment shall be in accordance with the terms and conditions of the attached Equipment Schedule. Unless any provisions in this Agreement are specifically excluded or modified in the Equipment Schedule, each Equipment Schedule shall incorporate therein all the terms and conditions of this Agreement, and may contain such additional terms and conditions as the parties shall mutually agree upon. The items of equipment listed in the Equipment Schedule, together with any repairs, replacements, or other substitution of parts, are hereinafter referred to as "Equipment." Each Equipment Schedule together with this Agreement shall constitute a separate rental agreement and shall be binding when duly executed by the parties, their successors, legal representatives and permitted assigns. In the event of any conflict between the terms of this Agreement and the terms of the Equipment Schedule, the terms of such Equipment Schedule shall govern.
2. Terms: The Lessee agrees to pay to the Lessor, or its duly authorized representative, the rental fee listed in the Equipment Schedule. The rental fee shall be paid as follows:
 1. Sixty percent (60%) of the rental fee will be due with order. For custom build-out orders or graphics 100% is due with order.
 2. An additional Thirty Percent (30%) payment is due 14 days prior to event set up.

 4. All invoices are discounted for cash. A fee of 4% shall be added to invoices paid via credit cards.
3. EXCLUSIVITY/RIGHT OF FIRST REFUSAL: At the show, event or exhibition contemplated under this agreement, Lessee agrees, except as otherwise provided herein, to exclusively use the equipment and/or event equipment and services available for rental by Lessor. Notwithstanding the foregoing, at the show, event or exhibition contemplated herein, Lessee may lease, rent or utilize equipment and/or event equipment and services from another source (other than Lessor), provided that the Lessee first gives Lessor the option to lease to Lessee such equipment and/or event equipment and services at the same price at which such equipment and/or event equipment and services are available from a party other than the Lessor, and such option is not accepted by Lessor. It is understood that Lessor's rental fee as stated herein has been discounted in consideration of Lessee's agreement to abide by this paragraph. Lessee further agrees that should Lessee breach the terms of this paragraph, Lessee shall pay to Lessor an amount equal to the rental fee which would have been charged by Lessor for the equipment and/or event equipment and services used by Lessee in the show, event or exhibition, in violation of this paragraph.
4. DELIVERY/SET-UP: Lessor shall deliver and set up the Equipment at the place designated by Lessee in the attached Equipment Schedule (hereinafter referred to as the "Facility"). Lessee is solely responsible to ensure that there is adequate access to the Facility. Specifically, Lessee shall insure that the Facility is equipped with the necessary freight elevators, freight doors and dock high accommodations. There will be a special handling charge, in addition to the rental charged, in the event that the facility's accommodations do not contain the necessary freight elevators, loading docks, and/or freight doors. Lessee shall be liable for the full rental and handling charges should the Lessor not be able to make delivery of the Equipment should the facility not have the required accommodations.
5. SITE INSPECTION OPTION: For an additional charge, Lessor shall inspect the Facility to determine whether it has adequate accessibility and accommodations, and shall become responsible for the delivery, set-up and dismantling of the Equipment, and shall, thereby, release Lessee from its duties and obligations under paragraph 6 entitled "Duties of Lessee."

Lessee further acknowledges Lessee's duty to inspect the Equipment prior to use and notify Lessor of any defects. Lessee is not obligated to take the opportunity to inspect the equipment at Lessee's discretion. Inspections shall be conducted by the event offer deadline as noted on the equipment schedule.
9. **REPLACEMENT OF MALFUNCTIONING EQUIPMENT:** If the Equipment becomes unsafe or in disrepair as a result of normal use, Lessee agrees to discontinue use and notify Lessor who will replace the Equipment with similar Equipment in good working order, if available.
10. **MERCHANTABILITY:** LESSOR MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESSED OR IMPLIED, AS TO ANY MATTER WHATSOEVER, INCLUDING, AND WITHOUT LIMITATION, THE MERCHANTABILITY OF THE EQUIPMENT OR ITS FITNESS FOR ANY PARTICULAR. Lessee acknowledges that Lessee is leasing the Equipment "As Is" and in good working order. Lessor shall not be liable, to any extent whatever, except as otherwise expressly agreed to in writing, for the selection, quality, condition, suitability, operation or performance of the Equipment or the maintenance thereof, nor shall Lessor be liable for specific performance or damages, if any for any delay of delivery of the Equipment beyond Lessor's control.
11. **SECURITY:** As security for the prompt and full payment of the rent, and the faithful and timely performance of all provisions of this Agreement, and any extension or renewal thereof, on Lessee's part to be performed, Lessee has pledged and deposited with Lessor the amount listed in the Equipment Schedule ("Security"). In the event any default shall be made by Lessee in the performance of any covenants contained herein, Lessor shall have the right, but not the duty, to apply the Security to the curing of such default. Any such application by Lessor shall not be any defense to any action arising out of said default; and upon demand, Lessee shall restore said Security to the full amount set Upon the expiration of the Agreement, or any extension or renewal thereof, and provided Lessee has paid all of the rent required herein and fully performed all of the other provisions of this Agreement, Lessor will return to Lessee the remaining balance of said Security.
12. **FILM AND VIDEO RIGHTS:** Lessee agrees to provide Lessor with copies of all video and film productions, presentations and/or advertisements wherein the Equipment is used either directly or indirectly ("Video.") Lessor shall have the right to edit and revise copies of such Video in any manner Lessor deems Lessor shall have the right to display or show such Video in any form to any of its customers or prospective customers.
13. **INDEMNITY:** Lessee shall indemnify and hold Lessor harmless from, any and all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including reasonable attorney's fees, arising out of, connected with, or resulting from the improper use of the Equipment, including without limitation, the manufacture, selection, delivery possession, use, operation or return of the equipment.
14. **OWNERSHIP:** The Equipment is, and shall at all times be and remain, the sole and exclusive property of Lessor; and the Lessee shall have no right, title or interest therein or thereto except as expressly set forth in this Agreement.

 5. Outdoor use without Lessor's express written approval, unless specified in the equipment schedule.
16. **ASSIGNMENT, SUBLEASES AND LOANS OF EQUIPMENT:** Lessor may not assign Lessee's rights under this Agreement without Lessee's consent, but will remain bound by all obligations herein. Lessee may not sublease or loan the Equipment without Lessor's written Any purported assignment by Lessee is void. Subject to the foregoing, this Agreement inures to the benefit of, and is binding upon the heirs, legatees, personal representatives, successors and assigns of the parties hereto.
17. **TIME OF RETURN:** Lessee's right to possession terminates on the expiration of the rental period as indicated on the attached Equipment Schedule. - 25 NON-WAIVER: Failure by any party to exercise any right, power or option given or reserved to such party hereunder, or to insist upon strict compliance with any of the obligations or conditions in this Agreement, shall not constitute a waiver of either party's rights to demand exact compliance with the terms of this Agreement. Waiver by either party shall not be binding, unless it is in writing and executed by the party sought to be charged and shall not affect or impair either party's right upon any subsequent default of the same or a different nature; nor shall any delay, waiver, forbearance or omission by either party to exercise any power or rights arising out of any breach or default by either party of any of the terms, provisions or covenants of this Agreement, affect or impair any parties' rights, nor shall it constitute a waiver of such party's rights hereunder or right to declare any subsequent breach or default.
- 26 COST OF ENFORCEMENT: In the event that either party initiates an action to enforce this Agreement, the prevailing party in such action or proceeding shall be entitled to reimbursement of its costs and expenses, including reasonable attorney's fees (including at the appellate level), whether incurred prior to or in preparation for, or in contemplation of the filing of such action or thereafter. All such expenses shall bear interest at the highest rate allowable under the laws of the State of Florida from the date the prevailing party pays such expenses until repayment.
- 27 ENTIRE AGREEMENT: This Agreement contains the entire agreement between the parties and subject matter hereof and there are no undertaking, agreements, representations or conditions in respect to subject matter, except as herein. No amendment shall be valid unless in writing, and signed by all parties. If it shall be found that any provision in this agreement violates any law government or government division having jurisdiction, such provision shall be of no force and effect, and this agreement shall be treated as if such provision had not been inserted herein. This agreement shall supersede all prior agreements between the parties.
28. GOVERNING LAW/VENUE: This Agreement shall be construed in accordance with the laws of the State of Florida and of the United States of America. Venue for any disputes arising hereunder shall be in a court of competent jurisdiction located in Orange County, Florida.
- 29 HEADINGS: The paragraphs and section headings throughout this Agreement are for reference purposes only, and the words contained herein shall in no way be held to explain or aid in the interpretation, construction, or meaning of the provisions of this agreement.
- 30 INVALID PROVISION: The invalidity or unenforceability of a particular provision of this Agreement shall not affect the other provisions hereof, and this Agreement shall be construed in all respects as if such invalid or unenforceable provisions were omitted.

Lessee assumes all responsibility for loss or damage to equipment during the period from delivery; or possession of the equipment, to removal or return thereof, the "rental period" Lessee will pay for all equipment lost or damaged in an amount equal to replacement or repair cost of the equipment.
