**D. Sponsorship letter that**

1. is an original. Copies **will not** be accepted.
2. is **not over** six months old from the date you plan to attend.
3. is a clear outline of specific dollar amounts and items the sponsorship covers.
4. contains billing instructions. (**Only sponsors who have a billing address located in the U.S. can be billed by the university.**)
5. is accompanied by a bank statement from any non-government sponsor indicating that the company has sufficient financial resources for sponsorship.

**E. Personal Sponsorship letter that**
